

## PART 4: Licensing, Reselling & Cottage Food Requirements


All vendors are responsible for obtaining and maintaining any required licenses and permits applicable to their products. While we will not be monitoring these requirements, we will not be held responsible for any repercussions from the city, county, or state.

### **Peddler's License:**

Vendors selling goods at the Quincy Farmers Market may be required to obtain a City of Quincy Peddler's License. It is the responsibility of the vendor to verify requirements and secure any necessary licenses prior to participating in the market.

### **Reselling Policy:**

The Quincy Farmers Market is a producer-focused market. Vendors are expected to sell products that they have grown, raised, produced, or made themselves. Reselling of commercially purchased or mass-produced items is not permitted unless approved in advance by market management.

#### **Adams County Cottage Food License:**

Vendors selling eligible homemade food items must comply with the Adams County Health Department Cottage Food regulations. A valid Cottage Food Operation Registration may be required, depending on the type of food product being sold. Vendors are responsible for ensuring their products and labeling meet all local and state health department requirements.

Failure to provide proper licensing or to comply with market policies may result in denial of participation.

*(Double booth spaces are subject to availability, must be approved by the Market Manager, and will be charged at double the vendor fee.)*


All double booth requests **must be approved by the Market Manager prior to acceptance.**
